A. Consider approving updated Administrative Policy 100.06 Base Salary Rates

Board Member Mike Casey moved to approve the updated Administrative Policy 100.06 Base Salary Rates. Board Secretary/Treasurer Brian Walker seconded the motion. All present board members voted in favor; the motion carried 4-0.

#### IX. REPORTS

A. August 2025 Financial Report

Division Chief Chris Russell summarized the August 2025 Financial Reports. An error in the recording of line items was discovered. Chief Russell and Ashley Smith are working with FMA Shared Services to correct the bookings. Board Secretary/Treasurer Brian Walker made a note for the record that there would be no action on the Financial Report until the errors are corrected. The Board of Directors requested amended Financials be sent to them upon completion.

### B. Departmental Reports

Division Chief Brad Ralston delivered the Prevention Division Report. They completed 85 business inspections, 27 site inspections, and 1 food truck inspection. Prevention completed 24 plan reviews; including 10 new construction and 4 tenant improvements.

Deputy Chief AaronWinkler delivered the Operations Report. In August, crews completed 476 total calls; 269 were EMS type and 207 were fire type calls. There were 7 PR events.

Chief Morley reviewed the citizen survey results. The hiring process remains open for 3 new firefighters and 2 additional positions to fill vacancies for 2026. The Type 3 Pumper is on its third deployment this summer with a crew of four firefighters.

Board Member Mike Casey moved to adjourn the meeting. Board Member Tamela Stockton seconded the motion. All present board members voted in favor of the motion; the motion carried 4-0.
