a. Resolution No. 2025-0003

Fire District Board of Directors Vice Chair, Mark Burdolski moved that sitting as the Governing Board of Fire District No. 1, to exceed the revenue neutral rate and consider adopting Resolution No. 2025-0003 authorizing a levy of property taxes in support of the budget Fire District No. 1 for Fiscal Year (FY) 2026 budget year that requires a property tax rate exceeding the revenue neutral rate of 1.339 mills for the Fire District No. 1 Debt Service Bond A Fund, and 1.049 mills for the Fire District No. 1 Debt Service Bond B Fund. Board Secretary/Treasurer Brian Walker seconded

the motion. Roll Call vote was taken; Burdolski-yes, Casey-yes, Stockton-no vote/absent, Walker-yes, Drovetta-yes. Resolution 2025-0003 passed 4-0.
